LIVE SCAN Quick Reference for Additional RTV field

- 1. Initiate Live Scan processing as via Dataworks Plus terminal as usual.
- 2. Capture fingerprints, palm prints and photographs as usual.
- 3. Enter all Demographic information as usual.
- 4. There will no longer be a Domestic Violence block to check
- 5. When you arrive at the charge field enter charges as usual.
 - a. You will notice two additional fields labeled Relationship To Victim (RTV). When you enter a charge that requires input on the RTV field they will be highlighted yellow. If box is not yellow continue as usual.

- 6. Continue processing as usual and submit fingerprints electronically to PSP AFIS.
- 7. If you wish to print (Not Required by PSP AFIS) the blocks will not be aligned unless you use the new Pennsylvania State Police Arrest and Institution Fingerprint Card, SP 4-123 (01/2019). You can print on the old PSP Cards if you use that as a record of the print and it will contain all entered information but be misaligned with the preprinted blocks. (Do not contact Dataworks Plus for alignment issues while using the old cards)

Manual Ink Fingerprint Quick Reference for Additional RTV field

- 1. Initiate Manual fingerprinting as usual, you can continue to use the old PSP FP Cards until new stock is available.
- 2. No need to fill out the Domestic Violence Block as it will be calculated upon submission to the Central Repository.
- 3. Fill out all available information.
- 4. When you get to the CHARGE section on the back of the card there may be additional information required.
 - a. You fill in the charge field as CHARGE/CITATION/COUNT/RTV (Relationship To Victim).
 - b. You only need Relationship To Victim (RTV) for those charges that currently have a Domestic Violence Flag in Criminal History, see attached list.
 - c. For charges requiring RTV information you will enter multiple counts on separate lines to ensure that RTV information is captured for each victim.
 - d. See attached table of RTV Codes
 - e. See below example of manual entry, it may be typed or handwritten.
