Jenkintown Borough Police Department has withdrawn from the accreditation program. It is the department's intent to apply again once they are able to get aligned with the PLEAC standards.

The Pennsylvania Office of Attorney General has requested a waiver of compliance for Standards 3.3.1, 3.3.2, and 3.3.3. Chief Benson directed the Standards Committee to review and make a recommendation at the January meeting.
